Water Supply for Mkwaru-kwaru

Nkomazi Local Municipality invites tenders for the construction of Water Supply for Mkwaru-Kwaru. In terms of section 110 of the municipal finance management Act 2003 (No 56 of 2003) tenders will be evaluated on 80/20 point system in line with Nkomazi municipality Supply Chain Policy. Part of the condition of this tender is that the service providers attention is drawn towards the requirement of MBD 6.2 (Local content) as per attached annexure in the document: as such all steel product and components are 100% respectively local manufactured.

It is estimated that tenders should have a CIDB contractor grading of 5CE or higher. In the cases of a Joint Venture every member of the Joint Venture should be registered with the CIDB and the lead partner should have a Contractor grading designation in the CE class of construction work and the combined Contractor grading designation calculated in accordance with the Construction Industry Development Regulations is equal to or higher than a contractor grading designation determined in accordance with the sum tendered for a 5CE class of construction work or a value determined in accordance with Regulation 25 (1B) of 25 (7A) of the Construction Industry Development Regulations.

Bid documents will be obtainable from, 11 April 2019, on payment of cash non-refundable document fee of R1096.00 per document from the offices of Nkomazi Local Municipality, Impala street, Finance Department, next to licensing Department, Malelane, Tel No (013) 790 1189 or Fax (013) 790 1476. Bid documents are available per arrangement from 08:00 to 15:00 (Monday to Thursday) and 08:00 to 12:00 (Friday).


